## 000.0 — ENERGY CODE ACE™ V-CLASS TERMS AND CONDITIONS

This section establishes guidelines for maximizing user experience and training effectiveness for participation in v-Class deliveries addressing Title 24, California Code of Regulations, Part 6: *Building Energy Efficiency Standards*.

- (a) I (hereinafter “I”) have taken the pre-v-Class Survey put forth by the parties responsible for the virtual class (hereinafter “v-Class” and not to be misinterpreted as a webinar, online self-study or any other such training, class or course conducted via the World Wide Web (also known or commonly referred to as the Web, Internet, CyberSpace, Ether, and/or but not limited to that thing Al Gore invented) entitled *Title 24 Part 6 Essentials – Residential Modeling* (hereinafter “Res Modeling”), and agree that:
1.     - B. Enabling<sup>1</sup> my audio by joining the class via telephonic communication device (hereinafter “Telephone”);
    - C. Actively participating in the course as appropriate and to the extent practicable through both (i.e., not limited to one or the other, but the two combined, although not simultaneously) speaking and listening to my fellow v-Class participants speak;
    - D. Working collaboratively with my fellow v-Class participants as assigned and designated as my break-out<sup>2</sup> groups while fully engaging in class activities as assigned by the class instructor (hereinafter “Class Instructor”);
